### **Ujeedo:- Dhaqan-gelinta Xeer Ir. 12 Midaynta canshuuraha dawladda hoose**

Anigoo fulinaya Xeerka lambarkiisu yahay 12 taariikhdiisu tahay 2/4/2000 laguna dhaqan geliyey degreetada Madaxweynaha JSL Ir. 25/2000 taariikhdeedu tahay 8/4/2000, waxaa la idin farayaa laga bilaabo taariikhda 15/4/2000 in qodobka 14aad xarfahiisa (b) iyo (x) ee xeer Ir. 12 aad canshuurta "Kabka Dawladaha Hoose" u qaadaan sida hoos ku qoran :-

1. Canshuurta kabka dawladda hoose waxaa loo qaadayaa 12.5% oo ku dhici doona isku-darka canshuurta **Fiscal duty and Sales tax**. Dakhliga ka soo hoyda canshuurtaas waxaa lagu darayaa dakhliga dawladda dhexe.

✓ **Tusaale ahaan:-** Haddii uu qiimaha badeecaddu yahay S/L 1,200,000-00 (Customs value) waxaa loo canshuurayaa sidatan:-

a) Fiscal duty	7%	=	84,000-00
b) Sales Tax	3%	=	38,520-00
c) Harbour Tax	3%	=	36,000-00
d) Kabka dawladda hoose	12,5%	=	15,315-00 (a+b)
e) Municipality tax	10%	=	15,852-00 (a+b+c)
f) Taakulaynta	2%	=	24,000-00
g) Stamp Duty	2.5%	=	5,342-00
h) Total duty		=	<b>219,029-00</b>

2. 10% kii ahaa Municipality tax ee kastamku hore ugu qaadi jiray degmooyinka badeecadaha ka soo degaan sida Berbera, Burco iyo Seylac waxay ahaanayaan sidoodii hore.
3. Sida ku cad isla xeer Ir.12 qodobkiisa 14aad xarafka (b) waxa kale oo la waajibiyey in kastamada kale ee aan hore ugu qaadi jirin degmooyinkooda Municipal tax ay hadda u qaadaan degmooyinkooda 10% Municipal tax oo ku waajibaysa isku-darka canshuurta Fiscal duty + Sales tax iyo Harbour tax. Waxay kastamadu maalin kasta ku shubi doonaan xisaabta degmooyinkaas uga furan bankiga degmooyinkooda islamarkaasna waxay ka qaadanaya General Receipt khasnajiga dawladda hoose ee degmadaas.
4. Waxaa la joojiyey ujeedadii ay degmooyinku u adeegsan jireen Kontroolada oo ahayd qaadista canshuurta badeecadaha debedda ka soo dega ama u dhoofa. Waxaa keliya oo kontrooladu u furnaan doonaan hab nabadgelyo oo keliya. Sidaas darteed waxaa reeban in canshuur kale laga qaado badeecadaha dalka soo gala ama ka dhoofa.
