LAW N. 9 of 4th March 1978 the acceptance of the Somali Democratic Republic to the I.M.C.O Convention.

**THE PRESIDENT**

**OF THE SOMALI DEMOCRATIC REPUBLIC**

HAVING SEEN : The 1st, 2nd, and 3rd, Charters of October 21st, Revolution 1969

HAVING SEEN : Law No. 1, 17, 18 and 19 of 1st. July 1976

HAVING SEEN : Articles 6 and 57 of the foresaid Convention.

CONSIDERING : The necessity to accept the Convention on Inter-Governmental Maritime Consultative Organization, done in Geneva on 6th March, 1948.

TAKING NOTE : Of the Approval of the Political Bureau and the Council of Ministers on 23rd, February, 1978.

Hereby promulgates the following law :

**Article I**

The Somali Democratic Republic hereby accepts the Convention on the Inter-Governmental Maritime Consultative Organization done in Geneva on 6th March, 1948.

**Art.II**

The Convention shall have the force of law in the territory of the Somali Democratic Republic in accordance with Article 60 of the Convention.

This law shall be published in the Official Bulletin of the Somali Democratic Republic.
