Decree no. 14, of the 9th February 1989: Instrument of ratification.

THE PRESIDENT OF SDR

HAVING SEEN: The Article 67, para 3 and the Article 82, para 4 of the Constitution of the Somali Democratic Republic;

HAVING SEEN: the Law no. 49 of 23 December 1984;

HAVING SEEN: The Law no. 11 of the 9th February 1989 on the base of which the People's Assembly has approved the Convention specified in this Decree;

HAVING CONSIDERED: The necessity to ratify this Convention.

HEREBY PROMULGATES

The following Decree:

Article 1

The United Nations Convention on the Law of the Sea and its Annexes, signed in Montego Bay, Jamaica, on the tenth day of December 1982, is hereby ratified.

Article 2

The above mentioned Convention and its Annexes shall have the force of Law in the Territory of the Somali Democratic Republic.

Article 3

This Decree shall come into force upon be published on the Official Bulletin of the State.
