- a) Hantidhawrka Guud wuxuu baadhayaa xisaab-xidhka sanadka oo uu soo gudbiyo Wasiirka Maaliyada siduu farayo qodobka 26^{aad} ee sharciga xisaabaadka dalka, iyo xisaab xidhka sannadka ee hay'adaha kale ee hantidhawrku awooda u leeyahay baadhista.
- b) Wasiirka Maaliyadda ee Dawladdu haddii uu warbixinta sanadka ee Hantidhawrka Guud uu ugu gudbin waayo isagoo raacaya habka iyo wakhtiga lagu cadeeyey qodobka 26^{aad} ee sharciga habka maamulka xisaabaadka dawladda, Hay'adaha kale ee Hantidhawrku awooda u leeyahay baadhista xisaabaadkooda haday ku gudbiyaan warbixintaa Hantidhawraha Guud habka iyo wakhtiga ku tilmaaman sharciyada loo dejiyey Xisaabaadkooda, Hantidhawraha Guud wuxuu warbixintiisa u gudbinayaa Madaxweynaha JSL.

- c) Hantidhawrka Guud markuu baadho xisaab xidhka sanadka ayaa Hantidhawraha guud wuxuu diyaarinayaa warbixin sanadeedkii hantidhawrka. Waxaana warbixintaas oo ay la socodaan nuquladdi cadaynta Hantidhawraha Guud ee suganaanta xisaabaadka uu u gudbinayaa Golaha Wasiiradda iyaddoo loo gudbin doono Golaha Wakiilada ugu dameyn 30ka june sanad kasta.
